Market closed positive 10-Jul-2025

#### **DSEX WENT UP BY 173.97 POINTS**

Market closed positive this week. Broad index DSEX went up by 173.97 points. Travel & Leisure, Life Insurance and Paper & Printing are the top three sectors that closed positive this week while no sectors closed negative this week.

Average turnover increased by 30.87% to BDT 6.4bn (USD 52mn). Bank sector dominated the turnover chart covering 19.04% of the total turnover.
